Dance Theatre

Initial _____: Annual Tuition

Annual tuition may be divided into ten equal installments, the first of which is due at the time of enrollment. These installments are based on 35 lessons and remain the same regardless of absences, holidays, weather cancellations, short months and/or recital dates. Tuition is prorated for students who enroll after the start of the year.

In the event a student must withdraw, prepaid tuition cannot be refunded except under extenuating circumstances such as moving out of town or long-term injury/illness, in which case fifty percent of annual tuition paid in advance can be refunded. Dance Theatre must be notified prior to the 1st of the month to avoid being drafted.

All monthly payments will be processed through automatic bank draft. This will require a bank account and routing number. The payment will be drafted the 1st of each month September-May. August is paid at the time of registration. Insufficient funds notifications will result in \$25 insufficient funds fee along with any bank fees assessed. Costume, recital and competition fees along with dancewear purchases can be paid by due dates via cash, check or credit card.

Annual tuition paid in advance (time of enrollment) will qualify for a 5% discount.

Initial _____: Costumes

Costume prices are \$60 each. To help parents budget, a down payment will be due in October 31st with the remaining balance due December 14th. Costume fees are non-refundable. Parents are encouraged to participate in the sizing process as the size ordered will be final.

Initial _____: Recital

A recital fee of \$25 will be due May 1st, and includes 4 complementary tickets (2 additional for siblings that also dance). The tentative date for this season's recital is May 20th.

Initial _____: Parking and Facility

Please only park in designated spaces, avoiding the grass. The lane in front of the building is for loading and unloading only, proceed slowly, little ones are not always as aware. Arrive no more than 15 minutes prior to the start of class to avoid overcrowding in the lobby.

Initial _____: Competition

Any class may be asked/surveyed about participating in a regional competition. Information will be provided prior to Christmas break. Class dances are a priority over individual solos, duos or trios. Dancers will not be allowed to "opt out" of a class dance and still compete in one of the above individualized routines.

Initial _____: Photo Release

I agree that Dance Theatre may use photos of my child with or without my name for any lawful purpose, including for example such purposes as publicity, illustration, advertising and web content.

Initial _____: Medical Release
